INDICATE PAYMENT OPTIONS BELOW. Annual dues must be paid in full by May 1, 2020

- Payment in full** – Due on or before September 1, 2019
- Semi Annual** – 50% of dues paid by September 1, 2019; balance will be invoiced on December 1, 2019.
- Quarterly:** 25% of dues paid by Sept. 1, 2019; balance will be invoiced in 3 equal installments on November 1, 2019, February 1, 2020 and May 1, 2020.
- Monthly** – 25% of dues paid by Sept. 1, 2019; balance will be invoiced in 8 (eight) equal installments on the 1st of each month, beginning on October 1, 2019 and ending on May 1, 2020.

Unless you opt out, invoices will be e-mailed to you from QuickBooks. This is based on the option you selected above. Payment by credit card or ACH debit can be made directly through this email.

Please note that mailing of High Holiday tickets is incumbent upon dues payments by September 1, in accordance with your requested payment option.

Please sign and return this agreement by June 21, 2019. If you are a 2 (two) adult household, both members must sign below.
