1. Meeting called to order at 7:33 PM

2. D'var Torah by Bret Jacknow

#### 3. Approval of Minutes

The minutes of the June Board meetings were approved, see www.thejewishcenter.org/Resources/Board-Minutes.aspx.

#### 4. Discussion of Federation Statement on H.R. 246 and BDS

- 4.1 Randy Brett introduced the discussion by referring to his recent congregational letter regarding a resolution passed by the US House of Representatives on BDS (HR 246). Feeling that this is a political matter, he left it to each congregant to determine her or his position on the resolution as well as the vote of our congressional representative. He has received a wide range of feedback on both the content and the propriety of sending the letter to members. Randy distributed a draft statement (attached at A along with the final, published, statement) from the Jewish Federation of Princeton Mercer Bucks. This statement was being discussed at a Federation meeting concurrently with this Board meeting.
- 4.2 In light of the proposed statement from Federation on the topic, Edye Kamenir withdrew the motion which had been distributed earlier in the week and proposed a new motion: "that we stand with the Jewish Federation of Princeton Mercer Bucks on the issuance of their statement on HR 246." Seconded by Kim Marks.
- 4.3 Lew Gantwerk felt that there was insufficient time to consider the distributed statement and moved to table discussion. Seconded by Abigail Rose. This motion was defeated.

- 4.4 A wide ranging discussion followed of the Federation's position statement, the role of TJC as a synagogue rather than a political organization, and how best to show support for Federation without sounding political.
- 4.5 An amendment to the motion was proposed by Judi Fleitman to prepend the phrase "Acknowledging that the Federation is the right vehicle for this type of expression" to the motion. Edye accepted this change. Further changes suggested by Robert Schwartz were also accepted. The amended motion read:

"Acknowledging that the Federation is the right vehicle for this type of expression, we stand with the Federation in its statement issued in support of the State of Israel and in opposition to BDS, and its appreciation of the action taken by the House of Representatives supporting the interests of the State of Israel on July 23, 2019."

- 4.6 Randy explained the Board by-laws on voting: officers have one vote; each committee has one vote shared equally among the co-chairs present; a person with more than one office or chair has one vote.
- 4.7 The motion was approved with 14 votes in favor, 3 against and 1 abstention.
- 4.8 Randy will send the Federation statement to the congregation with a covering note. He will say that the Board approved a motion in support of the Federation statement.
- 4.9 Bret Jacknow, Kim Marks and others noted that TJC remains free to make a public statement on this matter.

#### 5. **VP reports** – See Attachments

- 5.1 Finance. Warren Mitlak explained the financial dashboard and balance sheet:
  - the balance sheet shows the strength of TJC finances
  - the dashboard includes several items billed in this year where the work was performed last year. We will work on a policy to ensure that un-invoiced items are correctly accounted for in future budgets
  - school enrollment has been added to the dashboard. Nicole asked that last year's numbers be included for comparison
  - membership: Judi pointed out that only about half of expected commitment forms have been sent in so the numbers will increase in future.
- 5.2 Religious Affairs. Rabbi Feldman on behalf of Polly Strauss:
  - High Holiday planning is in good shape. Most aspects are unchanged from last year
  - Board members are encouraged to visit services other than the one they regularly attend and to provide feedback to Religious Affairs.

#### 5.3 Administration.

- Ed Simon was thanked for organizing the schedule of HH greeters, ticket takers, and ushers. Every Board member is expected to take at least one shift
- Board members are requested to respect the due dates for newsletter submissions (attached) and to work with (not around) Sandy Wilson
- Peter Smith and custodian Robert Torrez were thanked for the excellent renovation of the stage in the Social Hall
- Membership: Board members can help with recruitment by attending membership events

• Ed Simon explained the sign up procedure for HH greeters etc. There will be a practice run through on September 28 to familiarize everyone with their roles.

#### 6. **70**<sup>th</sup> Anniversary Gala

Linda Meisel spoke about preparations for the gala on September14. \$118,000 has been raised and costs are expected to be approx. \$50,000. The organizers are still seeking to sell tickets, sponsorships, and adverts. Thanks to generous sponsors some tickets are available for families and individuals who might be unable to afford the full price – anyone in this situation should contact Rabbi Feldman who will handle the matter in complete confidence.

#### 7. ULeague

Randy reported that August rent was paid. The League is very satisfied with Robert Torrez's custodial work on the facilities. We have no reason to change our view of the future arrangement.

#### 8. Other Business

- 8.1 Security: Randy reported that Michael and Beatrice Bloom have stepped down from their roles on the security committee having done a great deal of good work. He will appoint new leadership.
- 8.2 Randy will be out of the country until the end of August. As stipulated in the by-laws, VP Administration, Judi Fleitman, will be responsible in the President's absence.

#### FROM JEREMIAH TO THE JEWBU – ADULT ED TOPICS FOR ALL

You'll find a rich catalogue of Adult Education courses at TJC this year, with topics that span Jewish thought, history and the globe.

Professors returning by popular demand include Gary Rendsburg, the Blanche and Irving Laurie Professor of Jewish History at Rutgers University, with a three-session class dissecting "How the Bible Is Written" with word-play, alliteration, and even intentionally confusing language.

Does Judaism believe in an afterlife? Yes, says Reb Simcha Raphael, who will blend storytelling and mystical texts with a discussion of how we encounter death and think about the journey of the soul.

The prophet Jeremiah's legacy as an "influencer" from his own time to today will be the focus of a two-part class with Rabbi Robert Goldenberg, retired Professor of History and Judaic Studies at Stony Brook University on Long Island.

Would Jeremiah have predicted there would be people who identified as an American JewBu? Just as her book hits the stores in November, sociologist Emily Sigalow, Ph.D. will speak about contemporary Jews who are embracing Buddhism and claiming a dual religious identity. (Yes, you can Google JewBu.)
